Open Letter of Unity for Support in Amending SB252/HB1013

To The Florida Legislative Body & Governor Ron DeSantis:

In this increasingly radicalized culture, where laws around the country are easily overrun without consequence, and where the trampling of our most basic and cherished freedoms, by nearly all of our civic institutions as a result of the pandemic, was normalized:

WE THE PEOPLE of Florida, and specifically those of us in the Medical Freedom and Body Autonomy community, lift our voices and affirm this Declaration that we must have stronger language and broader protections over our medical freedom and body autonomy that cannot later be abused by an increasingly radicalized local, state, or federal authority—including a future Governor in our Great State of Florida. We hereby call all Florida Legislators, our Governor, and fellow Floridians to pay attention, demand real protections, and to properly amend SB252/HB1013.

We are invoking our God given, inalienable rights of life, liberty, and the pursuit of happiness, to decide what medicines, vaccines, and treatments we choose for ourselves and our families, with true informed consent—and without coercion, manipulation, propaganda, or threat of punishment. In a hospital and outside a hospital, the PATIENT'S RIGHT TO CHOOSE what to do with their own body needs to be paramount in the medical world in Florida. And this level of TRUE BODY AUTONOMY should be considered one of the most sacred of all rights, and not just a concept for COVID-19 related treatments.

Furthermore, we should not be tracked by our government or have our personal information and medical choices recorded and analyzed in any state, federal, or international databases. Ourselves and our loved ones, should be the only ones who need to know our vaccination, immunity, or medical status.

Additionally, no government or any other institution should not be able to force medical professionals into participating in procedures that violate their rights of conscience, nor should they be able to silence them from speaking out regarding their professional and moral opinions on patient care.

Because of these express desires and necessity to secure our own rights over our own bodies permanently, we are opposed to the current state of SB252/HB1013 which has already passed in the Senate and will soon be heard on the House Floor for a 3<sup>rd</sup> reading and final vote on May 2, 2023. Our immediate objective is to ensure no Floridians ever experience discrimination based on their vaccine or immunity status and to likewise ensure that Floridians are never subject to any vaccine mandates or vaccine passports. SB252 as it is currently written simply does not provide these protections.

To this end, WE THE PEOPLE of Florida demand the following changes/amendments to SB252/HB1013:

These lines must be removed or amended:

1. Section 9. Sections 381.00316(2)(g) and 381.00319(1)(e), Florida Statutes, as created by this act, are repealed June 1, 2025.

Amend: Remove Sunset Clause and make this permanent.

2. 381.00321 International health organization policies. — A governmental entity as defined in s.381.00316 or an educational institution as defined in s.381.00319 may not adopt, implement or enforce an international health organization's public health policies or guidelines unless authorized to do so under state law, rule, or executive order issued by the Governor under s. 252.36.

Amend: Remove “unless authorized to do so under state law, rule, or executive order issued by the Governor.”

There should be no use for a foreign entity to determine public health policy or otherwise within the United States of America, much less our great State of Florida. We don't need the World Health Organization (WHO), the Bill and Melinda Gates Foundation, or any other foreign governance or body to gain control over Florida's public health policies. Florida is a sovereign government and shame on anyone who would try to undermine our state sovereignty by subjugating our state to the whims of the WHO or any other “International Health Organization.” Acting as a true sovereign state, we cannot allow the kind of centralized power this statute enforces by “rule, law or executive order” to remain.

3. (c) For matters relating to vaccines other than those defined under subsection (2), a business entity shall provide for exemptions and reasonable accommodations for religious and medical reasons in accordance with federal law.

Amend: do not repeal the state exemption process but, revise to state “for matters relating to include all vaccines (within section 381 outlined below)” and to be a permanent protective process for Floridians.

The state should not repeal the current state vaccination exemption process outline in law under section 381. The state exemption process initiated at special session, in 2021, embedded in chapter 381, titled “Public Health Provisions,” should be amended now to include all vaccines, and to be permanent. Again, Floridians should never be handed over to the federal government, especially, with their poor handling of vaccine exemptions that destroyed millions of peoples livelihoods (Floridians lost their jobs at the hand of the Federal government) and destroyed our revered military! Moreover, the federal government mandated vaccines and weaponized OSHA against businesses.

Governor Desantis, let's keep our state sovereign and protect Floridians from a tyrannical federal government like you have promised you would do for the last several years in your many speeches and public appearances!

WE THE PEOPLE of Florida, and particularly the members of the following Freedom Groups representing over 700,000+ Patriotic Floridians demand that the aforementioned 3 changes be made to SB252/HB1013 to ensure Floridians are protected.
