

## The “Watch the Watchers” Action Plan

*“We know the problem: the surveillance grid is here. But panic is not a strategy—action is. Today, we aren’t just complaining; we are mapping the grid and exposing the contracts. Here are three simple things you can do this weekend.”*

### **DOCUMENT 1: The “Spot the Box” Visual Guide**

A simple infographic text to help people identify the hardware physically.

#### **IS THAT A FLOCK CAMERA? (Checklist)**

Don't let them hide in plain sight. Most people drive past these 10 times a day and never see them. Here is how to spot a Flock Safety Falcon:

##### **1. The Look:**

- The Shape: Looks like a black "bullet" or small cylinder. It is much smaller than a red-light camera.
- The Power: Almost always has a distinct, small solar panel mounted slightly above it.
- The Mount: Often found on random street poles, cheap metal poles stuck in grass medians, or HOA entrance signs. They are usually roughly 6–10 feet off the ground (eye level for a truck).

##### **2. The Location:**

- They are rarely at intersections (unlike red-light cameras).
- They are usually mid-block or at the entrances/exits of neighborhoods and shopping centers.
- They capture the back of your car as you drive away.

##### **3. The Behavior:**

- Does it flash? No. (Flock uses infrared, which is invisible to the naked eye).
- Is it big and bulky? No.
- IF YOU SEE IT: It has already seen you.

*We cannot fight what we cannot see. The government will not publish a map of these cameras, so we have to build it ourselves.*

## ACTION ITEM — MAP THE GRID

### Step 1: Go to DeFlock

Visit [Deflock.org](https://Deflock.org) (or use the OpenStreetMap platform). This is a community-driven database of automated license plate readers (ALPRs).

### Step 2: Log It

When you spot a camera (safe walking or parked—do not use phone while driving):

#### For the DeFlock app (Mapping Surveillance Cameras)

- Use the app: Open the DeFlock app (e.g., on your phone).
- Find the spot: Navigate to the location of the camera you want to report.
- Add a node (pin): Use the "add" or "pin" feature within the app to mark the camera's location, contributing to the public map.

### Step 3: Verify

Check your own neighborhood on the map. Is your street clear? If you see a camera *that isn't on the map, you are the first line of defense. Add it.*

**Note:** Do not trespass on private property to photograph cameras. Stay on public sidewalks/roads.

### Step 4: Share

Post photos and locations on local community boards (Nextdoor, Facebook and Telegram groups,) to wake up neighbors who are unaware they are being tracked.

#### Social media copy:

"Crime is the excuse; control is the goal."

"Flock isn't just a camera; it is an unconstitutional warrant machine."

"Ring doorbells are ending the Fourth Amendment by privatizing the police state."

### Step 5: Document: The "Paper Trail" FOIA Template

Purpose: A copy-paste legal request to force the city to admit the cameras exist and reveal who pays for them (Template on separate page).
